Steger Joins CAD, Gets NG Upgrades

he New Year may have arrived a few days late at the Steger Dispatch Center. But, on January 9, when Steger joined CAD and went live with new Next Generation (NG) consoles and equipment, there was still plenty to celebrate.


Although Steger has one of the smallest PSAPs in the Will County Emergency Telephone System – with seven full-time telecommunicators, they reportedly had the biggest of smiles on their faces when they took in their new surroundings.

In fact, "if trophies were awarded after NG upgrades, we probably would be cited for being 'Most Appreciative' and undergoing the 'Biggest Changes," said Steger PSAP Supervisor Mary Jo Seehausen.

4 Reappointed, 2 Added to 9-1-1 Board

t its February 19 meeting, the County Board of Will County approved the reappointment of four 9-1-1 Board members and the appointment of two new ones.

Sworn in at the 9-1-1 Board's February 26 meeting were Frankfort Fire Chief James Grady, who has been serving as Board chairman, East-com Director Pam Buzan, Peotone Police Chief (Continued on page 3)

120 Complete EMD Training

hen an improved EMD training program was introduced by the Will County Emergency Telephone System in 2007, the intent was to get all telecommunicators (TCs) certified in Emergency Medical Dispatch.

Eighteen months later (through October 2008), a total of about 120 dispatchers and other PSAP personnel had completed the EMD training, while 50 more still needed to complete the five- day class and become certified.

"With the help of input from our dispatchers, we have improved our training program," said Training Coordinator Joanne Burian. "So, it is encouraging to see that our PSAPs now have a greater commitment to training, and that more people are taking advantage of it.

"In the case of EMD certification, completing this course can mean the difference between life and death when

responding to a 9-1-1 call," she added.

"Since the 9-1-1 Board mandated that ALL dispatchers in Will County be EMD certified, we are encouraging all PSAPs to comply with that mandate – which means finding a way to give each dispatcher the release time needed to take the EMD classes."

(**NOTE**: The next EMD Certification class is scheduled for April 20-24 – from 8 a.m. to 4:30 p.m. each day at the Plainfield Fire Department, 15025 DesPlaines, Plainfield.)

In addition to becoming EMD certified, "it is important for



each TC to meet the 9-1-1 Board's Minimum Training Standards," said Burian. "These standards require a minimum of 12 hours of continuing education per dispatcher.

"In 2009, we want more dispatchers to enhance their professionalism by registering for and completing more training (see 2009 Training Schedule on page 4 or visit Will County 9-1-1's website: www.willcounty9-1-1.com).

"Remember that the 9-1-1 Board pays for the class registration fees and reimburses PSAPs for the hours their dispatchers devote to approved training," Burian said. ●

For example, after using the same, old equipment for all 14 of her years at Steger, Seehausen and her dispatchers are benefiting from the CAD system for the first time.

"This definitely has been a big revelation to all of us," she said, indicating that they have been accustomed to using punch cards (speedies) and hand-typing logs.

"Everything was done manually," she added.

Due to the NG upgrades, Steger's telecommunicators also are enjoying work at two new consoles.

Other big changes include:

- A new Positron phone system "Previously, we didn't even have caller ID," said Seehausen.
- A new radio system "Ours was dying; and we couldn't get parts or a maintenance contract," she said.
- A new voicelogger, which has meant "much less busy work."

"There is no one word I can use to describe the affects of these changes,

because the result has been an entirely different way of dispatching," said Telecommunicator Rachel Teneyuca, who has been a TC at Steger for nine years.

"What we have now is more efficient, provides us with access to more information – instantly, and simplifies recordkeeping," she said.

NOTE: In addition to Teneyuca, Steger's TCs include Christine Davies, Randy Johnston, Melissa Mieszczak, Bill Perry, and Jeremiah Stultz.

"We are very happy with the upgrades, but we also appreciate all the time and effort put in by Dale (Murray), Jim (Ariagno) and Joanne (Burian)" of the County 9-1-1 administrative staff, who were "here all the time," according to Seehausen.

"We were ready to go live with CAD in January because we had a head start using it during the 30 days we spent in temporary quarters," she said. "We were able to work out the kinks – even before two additional


days of formal training."

20,000 First-Graders Learn When to Call

Denita Draper Still Committed to 9-1-1 Education

pioneer when it comes to educating Will County residents about 9-1-1, Joliet Telecommunicator Denita Draper has led a city-wide program that has reached more than 20,000 first-graders during the past seven years.

The first 9-1-1 public education coordinator in Will County, Draper recognized the need for such an effort while visiting schools and reading to students as a Junior Achievement volunteer.

In 2002, after considering that experience, Draper approached her supervisors about creating a fun, entertaining, but highly educational program that would focus on how and when to call 9-1-1.

Draper helped select instructional materials and taught other Joliet telecommunicators how to make in-school presentations – which resulted in a test program that reached 500 first graders in about 20 classrooms at five elementary schools in Joliet District 86.

In 2003 – encouraged by the tremendous response to that initial effort – the program was expanded to include first graders in all 15 of Dist. 86's elementary schools.

Since then the program has been expanded further – to include parochial schools in Joliet, as well as public schools in Plainfield that are served by the Joliet Police and/or Fire Departments.

As a result, the number of schools participating in this program has increased to 29, the number of classrooms is now about 120, and the number of first-graders in thoses classes totals about 3,000.

Over the last seven years, approximately 20,000 first-graders have benefited from the program – which likely is a conservative estimate.

Among those who have joined Draper in making the 9-1-1 presentations are Joliet Communication Center telecommunicators Dawn Barfield, Virginia Bradley, Stephanie Brooks, Jennifer Chizmark, Andrea Delap, Heather Hanbaum, Francesca Hernandez, Susan Kljaich, Kacey Lauer, Marybett Marino, Theresa Saracco, Zelda Scott, Kim Smyth, Cindy Stukel, Kris Wilkerson and Lisa Yanchick.

However, Draper quickly added that "we wouldn't be able to schedule all the classroom visits without

the support of (Joliet Comm Center Director) Julie Ponce-Doyle, who has authorized the necessary release time" — which apparently has been time very well spent.

"Since we started making our 9-1-1 presentations to first-graders, we've noticed a reduction in the number of 'mischief' calls made by kids – such as those who dial 9-1-1 to see what happens," Draper said.

"Also, on several occasions, children who have dialed 9-1-1 and helped save a life have attributed their actions to what they learned in school."

Draper added that "such feedback really makes us feel good because it's an indication that what we are doing is making a difference."

In addition to her ongoing efforts with first-graders, Draper has made public-safety presentations to groups of Girl Scouts (Brownies) and other students.

Also, in 2007, she joined the Will County Emergency Telephone System's Public Education Committee, which is chaired by Administrative Assistant Caryn DeMarco.

Although she has been a telecommunicator for more than 20 years, Draper said that her first career goal was to become a teacher. Therefore, it's not too surprising that she's thinking of continuing her work as an educator after retiring from the Joliet Comm Center (hopefully no time soon).

Bill Mort, and Channahon Fire Chief David Riddle. Their new terms will expire February 1, 2012. Also sworn in were new appointees:

- Brad Veerman, director of the Lincolnway Public Safety Communications Center, who will be a PSAP rep and serve the remainder of Suzanne Modlinski's term, which expires February 1, 2011.
- Tom Weigel, a former 9-1-1 Board member who replaces

Richard Brandolino as the Will County Board rep.

A village trustee in New Lenox for 17 years, he was reelected to the County Board (District 2) last November.
His 9-1-1 term will expire on February 1, 2012.

Modlinski retired at year-end as director of the Lincolnway PSAP and as a 9-1-1 Board member. And Brandolino retired in November after 19 years on the County Board and seven years on the 9-1-1 Board.

The Board will elect officers and make committee assignments at its April 23 meeting.

PSAP Caller Activity Down Slightly in 2008

A fter 14 consecutive years of increased caller activity, the total number of calls handled by PSAPs in Will County's 9-1-1 Emergency

"Our telecommunicators handled 327,730 calls last year, which is about 0.4 percent fewer than the 328,959 calls answered in 2007," said 9-1-1 Chief Administrator Steve Figved, who attributed this decrease to 9-1-1 public education efforts that have helped to reduce the number of "mischief" calls.

Among the Will County system's PSAPs, Lincoln-

way experienced the greatest (7.7%) increase in caller volume in 2008 compared to 2007. Romeoville had the biggest decrease (7.9%). And Joliet handled the most calls (116,812), which was 815 fewer than in 2007. ■
