1. **Amendment #1**. An amendment to restrict the eligibility for the office of Chair or Vice Chair, by inserting the following language into Article VI. Section D:

No person may be elected as an officer of the ETSB, except from among the ETSB Membership. A PSAP Representative as defined in Article III Section C may not hold the office of Chairman.
